#### a. Social Constructivism

It is the interaction between social and practical elements in learning through speech and practical activities. This models advocate collaborative learning with peers and other adults.

### b. Classical Conditioning(Pavlov)

It refers to a learning procedure in which a biological content stimulus is paired with a new learned response in a person or animal. It occurs through association between an environment stimulus and natural occurring stimulus.

### c. Gestalt Principles of Learning

This theory states that objectives are perceived within an environment and the mind understands external stimulus as a whole rather than some of its parts.

This law deals with the Sensory Modality version. Here, learners are encouraged to discover the nature of a topic and solutions to the problems.
